PRIVACY POLICY

art. 13 of Regulation (EU) 2016/679 - GDPR (short version)

With this notice the Reggio Emilia Local Health Authority - IRCCS provides the most important information on the processing of personal data as part of its operations, in accordance with the provisions of current privacy laws.

The complete policy and all other information on the processing of personal data by the Reggio Emilia Local Health Authority is available on the health authority's website at the address www.ausl.re.it/privacy.

LEGAL BASIS FOR AND PURPOSES OF THE DATA PROCESSING

The personal data requested by the personnel are essential for the provision and management of healthcare services. They are used by staff who have been expressly authorised in accordance with professional and official confidentiality and according to the principles of privacy regulations.

As required by law, the processing of personal and health data is carried out by the Reggio Emilia Local Health Authority - IRCCS without the need to request the consent of the data subject for these purposes:

- Protection of your health, physical integrity and social welfare.
- Administrative, managerial and accounting obligations relating to your care.
- Healthcare planning, monitoring and assessment.
- Epidemiological and statistical activities.
- Certification activities.
- Management of reports/complaints/disputes.

Other particular processing of health-related data is only carried out if the data subject receives notice of another privacy policy and consents to other processing (e.g. for scientific research, for the activation of the Electronic Health Dossier, for the processing of genetic and/or biometric data, in the context of teleassistance/telemedicine, for the disclosure of data to the family doctor or other parties through the SOLE Network).

POSSIBLE DATA RECIPIENTS

To achieve the purposes indicated above and in the cases envisaged by law, personal data may be disclosed to public and private parties, bodies and institutions (e.g. facilities involved in the diagnostic and therapeutic treatment of the patient, Social Services, Law Enforcement and Judicial Authorities).

Information relating to health status may be disclosed to parties expressly identified by the data subject. Moreover, in the event of hospitalisation or treatment in the emergency room, it is possible to request that your presence not be disclosed to third parties.

METHODS OF PROCESSING AND DATA RETENTION PERIOD

Personal data are processed by computer or on paper and are protected to ensure they remain secure, confidential and accessible only to authorised staff. Other methods may be used (audio and video) as deemed useful on a case by case basis.

The data are nevertheless protected to ensure they remain secure, confidential and accessible only to authorised staff.

The data are stored for the time necessary to achieve the purposes for which they are processed.

THE RIGHTS OF THE DATA SUBJECT

At any time you can request access to your personal data, the correction of inaccurate data and the updating of incomplete data. Furthermore, in the cases and for the reasons established by law, you can request the restriction of the data processing and exercise your right to object to the processing. For this purpose, it is possible to submit a specific request to the Data Protection Officer by writing to the address dpo@ausl.re.it.

If the conditions are met, it is also possible to lodge a complaint with the Italian Data Protection Authority following the procedures established by such authority.
